### II. INSTRUCTIONS FOR INDIVIDUAL ITEMS

**Header Information:** Consists of key fields which uniquely identify each subject and recorded occurrence of a form. For the "ID NUMBER", record the 3-character, 6-digit number assigned to the specific participant. For the "Event", record if this is happening at Baseline or another event.

- **Item 0a.** Record the date the data was collected or abstracted in the MM/DD/YYYY format either by selecting the pop-up calendar in CDART or entering the date in the space provided.
- **Item 0b.** Record the SOURCE staff code of the person who collected or abstracted the data. This code is assigned to each person at each site by the GIC. If you do not have a staff code and are collecting SOURCE data, please contact the GIC in order to receive your own individual staff code.
- **Item 0c.** Record the start time (i.e., hour/minute) of the sputum induction procedure in the HH:MM AM/PM format in the space provided.
- **Item 0d.** Select only one option among the two possible choices. If 'Yes' is selected, go to Item 1.
- **Item 0e.** Select only one option among the five possible choices. If 'Other' is selected, go to Item 0e1.
  - **Item 0e1.** Specify other reason sputum induction was not performed on the participant in the space provided.

All options above with the exception of 'Other' in Item 0e, the participant may return within the 30-day window for the sputum induction.

#### If sputum induction was not performed, go to Item 30 after completing Item 0e.

- **Item 1.** Select only one option among the two possible choices. If 'No' is selected, go to Item 2.
  - **Item 1a.** Record the number of albuterol puffs given to the participant in the space provided.
- **Items 2-4.** Record the baseline FEV<sub>1</sub> value during pre-sputum induction the first, second, and third time it is measured in the space provided.

- **Item 5.** Record the name of the study staff or PI who reviewed the baseline spirometry measures in the space provided.
- **Item 6.** Select only one option among the two possible choices. If 'No' is selected, go to Item 23.
- Record the best FEV<sub>1</sub> value from Trials #1-3 in the first space provided for calculations. Then, select **Save and Reload** at the bottom of the page/screen, and CDART will multiply this value by 0.9 to prefill the second space provided. *NOTE: Use this CDART calculated value to determine if saline is to be increased to the next highest concentration for next inhalation period.*
- Record the best FEV<sub>1</sub> value from Trials #1-3 in the first space provided for calculations. Then, select **Save and Reload** at the bottom of the page/screen, and CDART will multiply this value by 0.8 to prefill the second space provided. *NOTE: Use this CDART calculated value to discontinue the procedure and give albuterol. Perform PFTs at 10 minutes post administration.*

## First 7 minutes measure:

- **Item 9.** Record the FEV<sub>1</sub> value at 1 minute at 0.9% NaCl. If FEV<sub>1</sub> drops less than 20%, continue.
- **Item 10.** Record the FEV<sub>1</sub> value at 2 minutes at 0.9% NaCl. If FEV<sub>1</sub> drops less than 20%, continue.
- **Item 11.** Record the FEV<sub>1</sub> value at 5 minutes at 0.9% NaCl. If FEV<sub>1</sub> drops less than 20%, continue.
- **Item 12.** Record the FEV<sub>1</sub> value at 7 minutes at 0.9% NaCl. If FEV<sub>1</sub> drops less than 20%, continue.
- **Item 13.** Select only one option among the two possible choices. If 'No' is selected, go to Item 23. *NOTE: If FEV*<sub>1</sub> *drops greater than or equal to 20%, then stop the sputum induction procedure.* 
  - Item 13a. Select only one option among the two possible choices. NOTE: If FEV<sub>1</sub> drops less than 10%, increase to 3% NaCl after the sample is collected. If FEV<sub>1</sub> drops equal to or between 10-19%, continue at 0.9% NaCl.

## **Second 7 minutes measure:**

- **Item 14.** Record the FEV<sub>1</sub> value at 1 minute. If FEV<sub>1</sub> drops less than 20%, continue.
- **Item 15.** Record the FEV<sub>1</sub> value at 2 minutes. If FEV<sub>1</sub> drops less than 20%, continue.
- **Item 16.** Record the FEV<sub>1</sub> value at 5 minutes. If FEV<sub>1</sub> drops less than 20%, continue.
- **Item 17.** Record the FEV<sub>1</sub> value at 7 minutes. If FEV<sub>1</sub> drops less than 20%, continue.
- **Item 18.** Select only one option among the two possible choices. If 'No' is selected, go to Item 23. *NOTE: If FEV*<sub>1</sub> *drops greater than or equal to 20%, then stop the sputum induction procedure.* 
  - **Item 18a.** Select only one option among the three possible choices. NOTE: If continuing, use the same saline concentration if FEV<sub>1</sub> drops equal to or between 10-19%. If FEV<sub>1</sub> drops less than 10%, use the next highest saline concentration.

#### Third 7 minutes measure:

- **Item 19.** Record the FEV<sub>1</sub> value at 1 minute. If FEV<sub>1</sub> drops less than 20%, continue.
- **Item 20.** Record the FEV<sub>1</sub> value at 2 minutes. If FEV<sub>1</sub> drops less than 20%, continue.
- **Item 21.** Record the FEV<sub>1</sub> value at 5 minutes. If FEV<sub>1</sub> drops less than 20%, continue.
- **Item 22.** Record the final FEV<sub>1</sub> value at 7 minutes, and the sputum induction is complete.
  - **Item 22a.** Select only one option among the two possible choices.

Remind participant to rinse mouth and cheeks thoroughly, gargle – spit into sink. Clear throat, scraping throat and roof of mouth – spit into sink. Blow nose – discard. Deep cough from chest and spit into sputum sample cup. DO NOT HAWK OR SCRAPE when producing sample. Passively bring it past the throat into the cup!

- **Item 23.** Record the time (i.e., hour/minute) the sputum induction procedure ended in the HH:MM AM/PM format in the space provided.
- **Item 24.** Select only one option among the two possible choices. If 'No' is selected, go to Item 26.
- **Item 25.** Select only one option among the three possible choices. If 'Other' is selected, go to Item 25a.
  - Item 25a. Specify other reason sputum induction was terminated early in the space provided.
- **Item 26.** Select only one option among the two possible choices. If 'No' is selected, go to Item 30.

NOTE: If the participant's FEV<sub>1</sub> dropped greater than or equal to 20% from baseline and/or if a second dose of albuterol was required, conduct a post-induction spirometry, and record the values in Items 27-29.

- **Items 27-29.** Record the FEV<sub>1</sub> value during post-induction spirometry the first, second, and third time it is measured in the space provided.
- **Item 30.** Select only one option among the four possible choices.
  - If 'No, Neither Induced or Spontaneous' or 'Yes, Spontaneous Sample' is selected, go to Item 30a.
  - If 'Yes, Induced Sample' is selected, go to Item 30b.
  - If 'Yes, Induced and Spontaneous Sample' is selected, **Go to End** of the form, and **Save and Close** the form.
  - **Item 30a.** Select only one option among the five possible choices.
    - If 'Other' is selected, go to Item 30a1.
    - If 'No, Neither Induced or Spontaneous' is selected in Item 30, go to Item 30b after Item 30a.
    - If 'Yes, Spontaneous Sample' is selected in Item 30, **Go to End** of the form, and **Save and Close** the form after Item 30a.
    - **Item 30a1.** Specify other reason an induced sputum sample was not collected in the space provided.

- **Item 30b.** Select only one option among the five possible choices. If 'Other' is selected, go to Item 30b1.
  - **Item 30b1.** Specify other reason a spontaneous sputum sample was not collected in the space provided.

Select Save and Close at the bottom of the page/screen.
